President's letter

Well, at last we are on the field and ready to start Season 2014 – Epping Eastwood Football Clubs' 62nd season.

First, let me say welcome to all of our new players from U6 right through to All Age (45's) and Premier League. We hope that your time will be a long, happy and productive experience with the Club. If you have any questions, suggestions or comments please let's have them. We will do our best to get you the answers.

Like all clubs we are made up of players, coaches, managers and officials. Most importantly we are all volunteers, all trying to provide you with the very best football experience.

Your management committee has been very active – even stretched in getting teams on the park. They have spent an extraordinary number of hours in preparation for Season 2014 and are to be thanked and appreciated for their efforts.

Volunteers come in all shapes and sizes and so do many things in the running of the club. Parents are an important part of volunteers. You may recall when you registered that one of the things you did was agree to help when requested for such things as assisting in the canteen and on the BBQ, in dressing and undressing of fields. Yes, we get some feedback, mainly from parents and we review our decisions. Let me stress people are invited to try out for Division One in any age group or can elect to play in say Division Three. I can tell you from experience that in many cases those in Division 3 are likely to finish higher on the tables at year end. Sure we would all like to strive for Division I. That said, let's recognise our ability and importantly enjoy what and where we play.

In closing on this topic I would like to thank this year's Grading Committee, so capably lead by our hard working Vice President Chris Salmon, and his team. As Scott McGoogan (our Club Registrar) would say "If it was that easy we would all do it". Thank you for your support.

The last topic in this letter is to talk about trial matches. Aren't we pleased they are behind us! Just ask Jarrod Mitchell who spends hours preparing the times and places, liaising with other clubs, sending the program then only to find that teams from the other club have withdrawn and then he has to start all over again! It's a necessary nightmare and we thank Jarrod for his hard work and patience. Also a huge thank you to McLaren & son who every Sunday moved and setup EBHS for the trials — a lot of effort.

ABOUT TALOODLES

Founded in 2013, Taloodles is a registered charity that is dedicated to acquiring and training conforming dogs to assist in the care and treatment of people who have a disability that is attributable to one or more intellectual, cognitive, neurological, sensory or physical impairments.

Australian Labradoodles are unique in many ways, they have been purpose bred and developed over many generations for genetic strength and temperament. They are loving, gentle and highly intelligent animals with allergy friendly, silky, non shedding coats.

The tempered personalities of the dogs chosen for Taloodles allow the puppies to enter foster care at approximately 8 weeks of age to begin their training, they live with their foster care families for approximately 7 months. The foster care families are volunteers who look after the needs of the dog and invest hundreds of hours in attending training sessions with professional trainers, continuing that training at home and taking the puppies into as many different environments as possible so that they are comfortable and relaxed at all times. It is a very special process which ends with the dogs being placed with the recipient family. We work towards placing the dogs with their recipient families by the time they are 7-8 months of age so that they can develop a strong bond with their family.



We have recently placed Taloodles Daisy, a 12 month old chocolate female, with Bianca who is 11 years of age. Bianca has high functioning autism, receptive and expressive language disorders in the severe range, cognitive and intellectual delay and Attention Deficit Hyperactivity Disorder – all of these disorders make every day for her family challenging as all these disorders can present simultaneously. Daisy has been living with Bianca and her family for approximately one month and has already had an impact on some of Bianca's behaviours.



Taloodles Milo, is an 11 month old chocolate male, who has been placed with Alexandra who is 15 years of age. Alexandra was a promising athlete, however, in January 2013 she sustained a deep brain injury in a skiing accident, she is currently unable to speak and is in a wheel chair. Milo has been placed with Alexandra to provide her with physical and emotional support to enable her to continue her physical and speech therapy.

FOR THE FIRST TIME


History is recorded in Season 2014 as Epping Eastwood moves into a new Age Division. For the first time we have entered a team in the Over 45 Division. The team is our former 35 Division team who have made the transition to 45 Division 1. For the benefit of some, here is a brief history. They have retained and added new players during the years they have been playing for the Tigers. The 90's was a "golden age" for this group of players playing Premier League being Premiers and or Champions for seven years of this decade and in 1994 they represented NSW in the Australian Amateur Championships in Adelaide and played against other State teams getting to the Grand Final. What an occasion that weekend in Adelaide was, one which your writer can still remember as the

one that got away.

In 2004 they moved to the 35's playing again in Division I and yet again under coach/player Peter Whiteside they won 4 Premierships, 6 Championships, 2 State Cups and a Champion of Championship title.

These boys/young men/adults have enjoyed a stellar career and have collectively given much back to the game they enjoy.

Under new coach Grahame McDougall assisted by Peter the boys now tackle the Over 45 Division I with some of the original players that started pre the 90's and we as a club wish them every success. It would be remiss of me not to mention player/manager Anthony Mitchell who has done an outstanding job for over a decade in looking after the administration of the team.



FOOTBALL

We're referring to the round ball game otherwise known as soccer - not the collisionheavy oval ball codes. Numbers of over 45s football players have been steadily rising over recent years, currently topping 8500 in NSW, according to Football NSW figures. Several of these players are pushing well into their 60s and beyond, prompting many clubs to increase their numbers of over 45s divisions and also consider adding over 55s options. Some of the clubs which have introduced smaller fields and shorter halves to make the game more accessible to young children, are offering similar conditions to keep seniors in the game. Football NSW CEO Eddie Moore says older football divisions give senior players the opportunity to socialise and be competitive at a "respectable speed".

"Being in that team environment gives you a chance to connect with other blokes your own age. This has great wellbeing benefits. You get the team camaraderie, not just the exercise on its own."

Claim forms are available on the GHFA or our club website. Your team manager has a leaflet that explains how it works. The claim form comprises several pages.

We always say private insurance is the way to go. However, you are encouraged to use the policy even if you are not claiming a rebate, at the least to have the injury recorded.

CHANGES TO PROTESTS AND DISCIPLINARY COMMITTEE PROCEDURES

There are significant changes to the method of how the Protests and Disciplinary Committee (P & D) will operate this season and those who know their way around what was previously in place need to revisit the procedure.

The actual procedure is some 28 pages which can be found on our website or that of the GHFA. I have to tell you that the present document has been looked at and modified by a number of scholars from the clubs including our own Chris Salmon who would be regarded as 'our expert' in this matter. Set out below is a simplified version of the 28 pages. In some respects the changes are procedural. That is how and when. All team managers have a copy and are encouraged to submit the 'EEW Incident Report' more than ever. It may be critical to how the alleged incident may be handled. Players who receive a red card should receive it without comment to the referee. The only person who can discuss the matter with the referee is the

Team Manager at the end of the game. They are entitled to ask the Code that the player is charged with.

It is vital that the player should not engage in any commentary. Likewise if you receive a red card leave the field of play immediately. Move away from the sideline and let your manager sort it out. In the heat of the moment further comments can only inflame the situation – red cards cannot be contested!

We are Epping Eastwood are proud to say that the number of incidents have decreased and that is good. We all want to enjoy the game – sometimes a challenge for the ball results in a careless tackle and we accept that. Foul language is not tolerated and certain words will get you a 6 week penalty. Attached is a list of the penalties. Enjoy the game – let's leave the whiteline fever at home!

<u>General Information for Clubs re – GHFA Grievance and Disciplinary Regulations</u> 2014

Committees and Tribunals

- 1. Disciplinary Committee (DC)
- 2. General Purpose Tribunal (GPT)
- 3. Appeal Tribunal (AT)

Disciplinary Committee

- The DC will deal with all red cards issued.
- A Notice of Suspension will be emailed to the players club as soon as practical after a decision is made by the DC
- Following receipt of the Notice of Suspension, the Club must notify the player and advise the player of the suspension.
- If the suspension is more than the minimum for the offence, the player's club may challenge the suspension under "Exceptional Circumstances" (7.4 of the GHFA G & D R)
- Any challenge must be lodged with GHFA by 10.00am on the Monday following receipt of the Notice of Suspension by emailing such challenge to nicole@ghfa.com.au.
- The Club when emailing a challenge must satisfy the DC that the suspension is exceptional and clearly excessive.
- The DC shall deal with a challenge of "Mistaken Identity" (7.4 of the GHFA G & DR) in a match officials send off or incident report.
- Notification of "Mistaken Identity" must be sent to the DC within three (3) days of the completion of the match or within three (3) days of receipt by the club of a match official's incident report.

General Purpose Tribunal

- The GPT shall deal with all incident reports and serious send offs directed to the GPT by the DC or General Manager. The GPT will also deal with any challenge referred to them by the DC.
- All decisions of the GPT will be conveyed by email to the player's club within two (2) days of the hearing.

Appeals Tribunal

- The AT will deal with all appeals from decisions of the DC and GPT.
- All appeals must be made in writing setting out grounds of appeal within seven (7) days of receipt by the club of the decision of the DC or GPT together with the relevant appeal fee (\$250).
